

#### INTRODUCTION




Odisha Forestry Sector Development Project-I (OFSDP-I) launched during 2006–2007 assisted by Japan International Cooperation Agency (JICA) with an objective for restoration of degraded forests through Joint Forest Management (JFM) for sustainable forest management and poverty alleviation of poor and forest dependent communities by diversifying the means of livelihoods and to reduce the extent of their dependency on the forest resources.

Drawing on the lessons learnt from the success of OFSDP-I, Odisha Forest, Environ-

ment & Climate Change Department, Govt. of Odisha through Government of India, proposed OFSDP-II to achieve sustainable forest management, biodiversity conservation and improvement of the livelihoods of the community beyond the area covered under OFSDP-I. A detailed Project Report (DPR) was submitted by the State Government during the year 2016 and OFSDP Phase-II Programme (OFSDP-II) launched in the year 2017-18 for a period of 10 years till 2026-27, with soft loan assistance from JICA (Japan International Cooperation Agency).

#### PROJECT OBJECTIVE

OFSDP-II aims at enhancing forest ecosystem along with sustainable lelivelihood of the local people by improving sustainable forest management, sustainable biodiversity conservation and community development, thereby contributing to harmonisation between environmental conservation and socio economic development in the project area.



### RATIONALE, SCOPE AND CHALLENGES BEHIND ENGAGEMENT OF LOCAL NGOS AS PARTNER IN PROJECT IMPLEMENTATION

OFSDP-II is a flagship programme of the State targeting of 1200 Vanasurakshya Samitis in 12 Forest Divisions spread over 50 Forest Ranges under the project Fold. The project interventions include forestry development and participatory forest management, farm forestry, biodiversity conservation, livelihood enhancement, human-wildlife conflict management, institutional capacity building, etc. The project envisages working with 3600 Self Help Groups for Livelihood enhancement activities at the VSS level and also with the producer groups formed by these SHGs at the cluster level for higher level livelihood enterprises.

The VSSs as the building block of the project are the primary unit of the project implementation. The project intends to strengthen the VSS as an empowered democratic village institution for forestry governance. It desires to build the capacity of the VSS so that they will continue to carry different activities for forest management within the legal and institutional

frame work. The project emphasizes the rigorous engagement with the target communities, PRIs, other line Departments and private players for implementation of different activities through convergence.

With the limited human recourses and skill set particularly for livelihood enhancement and ensuring community participation and their involvement in the true sense & spirit of Joint Forest Management which needs rigorous community mobilisation and capacity building of the local people. It would be difficult for the part of the Forest Department (FD) alone to implement all the interventions planned under project with such limitation. Hence, the need for engagement of local NGOs was felt necessary to play as partner in the project implementation to compliment the activities of FD in decentralized participatory forest management, and focus intensively on community institution building, addressing the issues in institutional sustainability at the community level, diversification of livelihood activities

dependant communities. Therefore, partner NGOs have been associated with the project since beginning of OFSDP-I and now also in OFSDP-II. The Partner NGO deploys Quality Human Resources for implementation of Project interventions. In OFSDP-II, one Partner NGO is engaged in a Project Forest Division called Divisional Management Unit (DMU). The said NGO deputes one team of of 3 members' staff to each Forest Range associated under project called Field Management Unit (FMU. The teams deployed by the PNGO to FMUs in a DMU function under the direction of Divisional Management Unit (DMU) Chief and guidance of Filld Management Unit (FMU) Chief.

The key objectives of engagement of Partner NGOs are to ensure institutional strengthening and sustainability of VSS and SHGs so that they would be managing the assets created / developed by the project in an equitable and sustainable manner and to enhance the participation of VSSs and SHGs in the project planning and implementation of project activities. The Partner NGO would also ensure the rigorous engagement of SHGs in different livelihood activities round the year to enhance their members' income and to reduce the risk of livelihood insecurities.

The broad perspective of Partner NGOs work coverage area includes the following:

- Community mobilization.
- Reorganization/formation of VSSs, EDCs and SHGs.
- Micro planning, annual planning and convergence planning.
- Capacity building of VSSs/ EDCs and SHGs.

- Assistance in implementation of different project activities: Afforestation, farm forestry, biodiversity conservation, livelihood enhancement, community development, building interfaces with different stakeholders, etc.
- Business/ enterprise planning for the SHGs and implementation of business/ enterprise plan and efforts for institutional sustainability.
- Monitoring, performance reviews/ assessment and evaluation at VSS level.
- Documentation
- Knowledge Management

The task assigned to PNGO is very crucial and challenging for effective project implementation and ensuring project output as the people's participation is key to achieve the target output of the Project through JFM mode. The combined GO-NGO partnership approach to deal with community on forestry sector development programmes is an innovative effort made by JICA projects in India and 1st time in Odisha since 2006 through OFSDP -I. The GO-NGO partnership arrangement is a successful community approach model proven over the years in implementation of JICA-Forestry Projects. Even the Department runs "Ama Jangala Yojan" a State owned Forestry Development Scheme through GO-NGO partnership model.

"NYSASDRI" being the partner NGO in Dhenkanal Forest Division working in OFSDP-II since 2017. The Organisation would like to share glimpses of its rich experiences gained over 4 years of implementation of project activities. The Organisation has deployed 18 personnel in 06 teams to work in six FMUs (Dhenkanal, Hindol, Kamashya Nagar East, Kamakshya Nagar West, Sadangi and Kapilash) adopted under Dhenkanal Forest Division. Each PNGO team consists of one Team Leader from Institutional Building and two Development Officers including of a lady officer by default from community development background. They all have stationed at their respective FMU HQs and operate from the FMU Office functioning under Department.

#### "NYSASDRI" STAKES AS PARTNER NGO IN PROJECT INTERVENTIONS

"NYSASDRI" is based at Dhenkanal district since1983 discharging duties in Education, Health, Rehabilitation, Women and Child Development Natural Resource Management like Land, Water and Forestry Sectors etc. The Organisation gained popularity in the district for its innovative approaches and contribution in eye care services to rural poors through establishment of Kalinga Eye Hospital at Dhenkanal. The organisation is famed for undertaking several socio economic develop-

mental activities in different sectors over the years. In forestry sector Development, "NYSASDRI" has been playing a pioneering role since beginning of the organisation for protection of Forest and Wildlife through community forest management concept. The organisation showed interest to join hands with OFSDP-II because of the Organisation's mandates matched with project objectives for ensuring JFM.



#### (a) Reformation of Vanasurakshya Samits (VSSs)

Field implementation starts with activities of selection and finalization of villages to be adopted under project. It is crucial to enhance and strengthen livelihood of the forest community who are highly dependent on forest ecosystem. The second priority is to address the forest degradation and ultimately to conserve forest eco-system. The project has the target of 150 VSSs to adopt under OFSDP-II in the Division. The selection of appropriate target VSS and population for smooth implementation of project activities from the point of view of community mobilisation was the prime task entrusted on the PNGO. There was a pressure from adjacent VSSs of a select-

ed VSS demanding to include their villages under the project. Under such circumstances, P-NGO teams have rigorously visited to almost all the villages where the VSS have been formed. Meetings have been conducted in the villages to assess the people's responses, dependency on forest, intensity of forest degradation etc. It is observed that many villages, the VSS formed are not functioning effectively due to lack of external supports to them. The Executive Committee (EC) members of the VSS occasionally sit/never sit in a meeting. Very few VSS found to see received small funds from department for some plantation activities but not many.



The PNGO team made their sincere effort to select appropriate villages in consultation with Forest Department followed through a set of selection criterion prescribed under the project. The table shows the status of VSS adopted in six FMUs. The PNGO Team immediately reformed the selected VSS to activate them in the principle of JFM Resolution 2011 and revised in 2015, to implement the project activities. The election process for reformation of VSS EC was done very appropriately, through a democratic and effective participation of villagers in Palli Sabha guided by the Joint Forest Management Resolution. The PNGO team played a very pioneering role in

ensuring the election process goes in the right direction. The reconstituted Executive Committee members are oriented by PNGO team time to time to perform their duties and responsibilities. The detail area coverage and list of adopted villages given in *Annexure-I &*II

#### (b) Engagement of VSS Animators

Each selected VSS under the project provision has to employ two educated youths to work as VSS Animator at their village on monthly payment basis. One must be a lady animator among the two. They will work closely associated with VSS on monthly payment basis. A lot of pressure was there on the PNGO how to select the Animators and engage them with-

out the outside influences & conflicts within the village. The PNGO teams educate the VSS EC to go far a selection process. A notice was served in the village by VSS to apply for the post. Accordingly the VSS with help of PNGO team undertook a selection process in each VSS to select and engage the animators and process was smoothly managed the VSS.

#### (c) Survey, demarcation & pillar posting

The villages where VSS constituted have been assigned with areas for community forest protection. Traditionally the villagers who depended upon a particular forest area for meeting their day to day requirement from the forest, they have been assigned with that forest area by the department for protection. The



VSS associated with Project have been provided with minimum 50 ha. to 200 ha. Forest area for protection. Previously there was no proper boundary demarcation of the assigned areas. The conflict arises where there is a common boundary of two or more VSS. This problem was addressed under the project intervention through the PNGO and Department effort. The assigned area of each of the 150 VSSs has been surveyed and demarcated by the posting of RCC pillars. This is actually a hard task where lot of efforts being required to gain the people's cooperation, their involvement in the survey demarcation process. Many places the conflict situation arose during survey time between a VSS with its neighboring VSS.

#### (d) Micro plan preparation

In order to achieve sustainable forest management in JFM mode, it is important that the micro plan is holistic and addresses wider needs of the forest depended communities. OFSDP-II adopted an approach to develop the micro plan at the VSS level as a platform for optimizing community development activities in addition to the sustainable management of Forest at side by side ensuring optimum convergence with other Govt. schemes / programmes. The very purpose of preparing Micro Planning in Forestry Sector Development Programmes is to empowering the communities to evolve as a responsible institution and understand the problems and challenges in sustainable management of resources, inter sectorial convergence, poverty reduction and development and their strength and weakness with a specific focus on forest conservation, biodiversity conservation, farm forestry, and sustainable forest management. Micro planning includes village perspective planning and forest development planning each to be prepared for a period of 10 years for each VSS specific, for project implementation. It was a great challenge before P-NGO to prepare the forestry based Micro plans as

per the project objective and requirement and to achieve the objective of perople's participation for JFM. The PNGO team shouldered such responsibility of preparing VSS to prepare the plans. The PNGO teams have formed the 'Micro Plan Working Groups' and "Women Working Groups" in the villages to ensure the participation of the villagers maintaining the gender mainstreaming in the mocro planning process. Near about 20 persons selected in each VSS for all 150 VSS associated under project who are imparted with training at community level in an organised manner for their involvement in the planning process. It was great achievement through project to educate such a large section of community on micro planning process. The PNGO team also contacted and involved the PRIs and Line Department officials in the Micro Planning procees to asses the community needs to address through convergence. The PNGO team could enable to complete the micro plans preparation for all VSS within time frame. 150 Micro Plan approved documents are ready and shared at different levels of PMU, DMU, DAC, BLAC and Grampanchayat and appreciated at all levels.









#### (e) Capacity building training programme

Strengthening the VSS to work appropriately as an institution for JFM is the prime focus of the project interventions. SHG is the right kind of institution grown up at VSS level for livelihood interventions. Both the institutions need their capacity building to manage and fulfill the twin objectives of the project. The PNGO teams are very conscious about effectively managing their roles and responsibilities for conducting of the capacity building programmes for the VSS/SHGs as to strengthen institutions to effectively play their role in project implementation. The teams has given importance on preparing training modules in odia suitable to their local language and impart training through use of Audio Visuals Aids and pictorial methods. "NYSASDRI" apart from the project provisions, organises different awareness camps, exposure etc. for community from own fund and through convergence. The organisation has also organised a training programmes for the VSS animators from own resources. The PNGO has contributed its own building/training hall at free of cost for conducting of many training programmes carried out under project. The orientation/training so far imparted by the PNGO to VSS Animators, members and SHGs are on community mobilisation, Survey Demarcation, Preparation of Micro planning, SHG/ VSS book keeping, IGAs, farm forestry etc. There is vast scope under project to impart a lot of training programme to community on livelihood development options in which the PNGO team will definitely contribute effective as the PNGO teams are capacited enough to fulfill the capacity building requirement of VSS/SHGs. Details of training and exposure to VSSs/SHGs is given in Annexure-III



#### (f) Extension of farm forestry

Farm Forestry component aims at improving the tree cover outside the forest area which also contributes to improvement of livelihood among the VSS members. In Dhenkanal Forest Division about 1200 ha area has been targeted to cover under far forestry in private land of the farmers. It is seen difficult to motivate farmers to go for tree planting in their lands. The PNGO teams have visited all the project villages conducted meeting with farmers and identified their lands in phased manner to implement such programme. In Batch-I and Batch-II, target achieved was lagging be-

hind as the concept was new to win confidence of farmers. J K Paper Mill, Rayagada came forward and with their co operation, the PNGO team motivated the farmers to go for plantation of eucalyputs which can fetch income within a period of 4 years for which JK Paper Mill provides the buy back guarantee of trees. As a result of which the project can meet the target under farm forestry. Farm Forestry is already implemented in Dhenkanal and Hindol FMUs. Other four FMUs are under progress for implementing such componet.

#### (g) Sustainable forest management

Sustainable Forest Management includes the below mentioned activities which has been implemented through VSS with the technical support provided by Department and under the guidance/supervision by PNGO Team:

- JFM mode site specific plan (SSP) & Monitoring
- Drainage line Treatment (SMC works)
- Assisted Natural Regeneration (ANR)
- Block Plantation
- Nursery Raising
- Fire protection

The hard task with PNGO that to organise VSS, orient them on the concepts and motivate them for undertaking of activities. Even if the task was very top because of the skill involved for execution of work, the PNGO teams have proven their efficiency ensuring the people's participation undertaking the activities of Sustainable Forest Management. In

due course of time, the PNGO staffs as well as the VSS members are skilled enough to supplement the Department. Due to the effective roll played by the VSSs facilitated by PNGO support and Departmental guidance, the plantation of about 6300 ha has been possible to achieve planting of 2440000 seedlings in the VSS assigned area over a period of 3 years through effective community mobilisation. The table below shows the status of Plantation taken up through Project.

The VSS are now trained up undertaking Drainage Line Treatments through construction of Lose Boulder Check Dams (LBCD) towards conservation of Soil Moisture in the forest area. Forest fire protection activities and Nursery raising techniques are also managed through VSS with the help of PNGO and Department support.

#### (h) Livelihood improvement


Livelihood Improvement is an integral part of the project Implementation. Providing sustainable livelihood options to the poor / forest fringe people is one of the thrust areas of the project. Project follows two way mechanisms to empower VSS enable to provide livelihood supports to its members. One is through convergence with line Departmental Govt. programme /schemes and other is through direct project support for undertaking different Income Generating Activities mainly by SHGs/Communities.

PNGO as the specialised institution for facilitating the livelihood support to community and being the motto of project behind engagement of the NGO in OFSDP, with this sprit, "NYSASDRI" took the sole responsibility on his part for successful management of the livelihood programmes.

During the initial years, project has no provision of funds to carry forward the Income Generation Activities. The PNGO teams of "NYSASDRI" took the challenges of bringing various Govt. Schemes / Programmes to VSS tied up with Agriculture, Horticulture, Veterinary, OLM, Mission Sakthi etc. Under convergence, the VSS members have got the benefit of free supply of seeds, fertilizer and agricultural impalements, Horticultural Nursery Plants, Vermiculture Pits etc. By the support of Panchayat Raj Department/MGNREGS, OLM & Mission Shaki, different loan supports to SHGs, Mo Upakari Bagicha, land development support etc. have been provided to the VSS members. With the help of Health Department and Kalinga Eye Hospital, Dhenkanal a lot of health and eye check up camps have been taken up by PNGO support.



The Project has provided the Revolving Funds support to VSS in the fourth year of implementation. The SHGs have been identified in VSS level to undertake the activities. The products available in the VSS area have been mapped out for undertaking of IGAs. The project envisages to upgrade some potential products in cluster mode by club of SHGs for which Cashew and Honey have been identified. The individual SHGs, CIGs, and Poorest of Poor Persons those want to take up small IGAs by their own can also be provided with loan support from VSS Revolving Fund. Under such context, the training to VSS member are being imparted to manage Revolving Fund and release of Loans to SHGs/CIG or Individuals. Operating the livelihood activities is a prime task recently under operation. "NYSASDRI" concentrates now on the livelihood promotion activities by way of facilitating VSS for preparation of Business Development Plans (BDPs), loan release from Revolving Funds, record keeping etc. for smooth management of IGAs. Details of important convergence works is given in Annexure-IV



#### VSS solved drinking water problem in the village

Kathagada Ragadisahi VSS under Dhenkanal FMU is a small village under Dhenkanal Municipality. Most of the families are Scheduled Caste and Forest Dependent. VSS participation in project activity is good enough. The only source o Drinking Water is the bore well in the village. The VSS building is constructing near the bore well only for that water facility available.In April 2019 the bore well got defunct suddenly? VSS members met the Municipality officer many times for its repair. But the requests got unresponded. In a VSS E.C meeting held by the P-NGO mainly on the issue, a resolution was passed in the VSS meeting and submitted before the Junior Engineer, Dhenkanal Municipality for immediate action. On next day the P-NGO team met the

J.E, Municipality and requested for immidiate repairing of Bore well. The J.E was convinced visited the spot after two days and sent their technician to repair it. After repairing the VSS members expressed their gratitude to the J.E and Municipality for their kind help to the VSS.Also by the support of the P-

NGO team the electric wire sagged over the VSS building was displaced by posting of two numbers new electric poles. The P-NGO team assisted the member secretary with a group of VSS members to carry out the poles from Mahisapat electric section office. The electrical J.E was appreciated for the cooperation of the people in displacing the poles.



#### **World AIDS Day observed by VSS Members**

An awareness campaign was organized on the eve of "WORLD AIDS DAY" on 1st December 2018 at Kuspada VSS of Dhenkanal FMU. The PNGO team arranged a programme with



cooperation of the students and staffs of NYSASDRI School of Journalism & Social Work to create awareness among the people of Kusupada village. The forest fringe village Kusupada is very scat-

tered from the District Head Quarters, belonging of Schedule Tribe families who are mainly dependant on forest for their livelihood and most of the young men are seasonal Migrant. The young men are migrating to outside states to earn their livilihood every year. At the time of returning to the village it is observed that some of them are affected by vari-

ous contagious diseases like HIV, TB, FLU, etc. Observing such scenario in the village the PNGO team tried to arrange the programme to spread awareness on the deadly disease called AIDS on "WORLD AIDS DAY" this year. PNGO team members with the group of students of NSJS, Students of Kusupada primary school, VSS members, and Forest department staffs organized the rally by displaying awareness plaque cards, banners, posters and slogan related to safety measures for STD, contraception, unhealthy sexual intercourse and prostitution. Our team had family counseling with the young and migrant male female mass living in the village imparting the basic knowledge about the disease AIDS. At the end of the programme, the students of NSJS performed a street play on prevent AIDS and lead a healthy life.

#### Free Mask distribution in VSS

To meet increased demand for mask in VSS, 2 SHGs are working to stich the mask and supply to VSS members. In Gajamara VSS Mahima Radha Krishna SHG and in Khathagada Nuasahi VSS Sundarasuni SHG are involved in Mask preparation and free distribution within the VSS. They are manufacturing cotton cloth mask at reasonable price of 10 rupees per piece to the outside VSSs.



#### **International Youth Day observed by VSS Members**

An awareness campaign has been organized at NYSASDRI office Dhenkanal on the eve of International Youth Day on 12th August 2020 by the coordination of PNGO NYSASDRI Dhenkanal. PNGO team arranged a programme with cooperation of the students and staffs of NY-SASDRI School of Journalism & Social Work. The theme of International Youth Day 2020, "Youth Engagement for Global Action" seeks to highlight the ways in which the engagement of young people at the local, national and global levels is enriching national and multilateral institutions and processes, as well as draw lessons on how their representation and engagement in formal institutional politics can be significantly enhanced



#### Livelihood support in assistance of UCO RSETI

In Kusupada VSS all households are ST family and depending on forest. P-NGO team planned to organize a training programme on goat rearing to enhance their livelihood. On 16.11.2020. A training programme was organized with support of RSETI, Dhenkanal. 28 VSS members participated in the training program. It was a "10 days training program" conducted in Kusupada VSS. The main objective of this training program is to provide handhold support to any unemployed youth in the age group of 18-45 years having aptitude to take up self employment



#### Bhagabata Jew VSS, JFM area development

Bhagabata Jew VSS of Makuakateni VSS in Kamakhyanagar East is assigned with forest area of 155 ha. Under the project interventions, 64 ha was taken up for plantation under components of ANR and AR intervention. 3030 man-days have been generated as a part of livelihood improvement of Bhagabata Jew VSS members 65 ha. Plantation activities with 30,700 seedlings planted with different species in different treatment area like: ANR (Arjun , Jammu , Neema) , Fuel Fodder (Gambhari ,

Mundi, Mehegani, Asawastha, Bahada, Sisoo, Kaitha, Sirisa, Fasi), NTFP(Amla, Karanja, Bahada) has planted for forest growth and ecological balances. Now an afforestation programme has been initiated inside the Fuel Fodder treatment area in 7 ha.

Plantation taken up in the VSS is inaugurated by Sub-Collector, Kamakshya Nagar as Chief Guest in presence of Range Officer, P-NGO Staffs, and Forest Dept. Staffs and VSS people.





Towards sustainable Forest management & protection of ecosystem

Loknathpur VSS under FMU, Hindol is surrounded by Bampa Reserve Forest. The Vana Surakhya Samiti was formed in the year 2005, the VSS included by OFSDP-II in the year 2018. Since inception, the villagers have been protecting their forest area in rotational basis. Plantation, SMC work, and NTFP collection

by the VSS member have been taken of by the VSS in a collective way . The degraded patches have been regenerated taking plantation like-ANR- 25 Ha and AR-5 Ha. The forest cover has increased by the collective protection by the VSS members which is a healthy sing towards a healthier Biosphere and Livelihood





#### **Convergence activities by Hindol FMU**

Inter sectorial convergence is one of the important activity being pursued by VSSs implementing the OFSDP-II. During the reporting period, many activities have been undertaken in convergence with various departmental schemes and programs. Renovation of ponds, drinking water facilities, construction of Farm ponds in Illirisinga and Fasigaon VSS, renovation of pond Lahada VSS, implementing Mo Upakaribagicha programme in 17 VSS,

Construction of park, construction of play-ground, ajola pits, construction of roads, organizing animal and human health camps, IGAs for individual members and groups such as Bank Loan support, Convergence for skill building under DDU-GKY,OLM, Distribution Vegetable crates help of Horticulture Dept., construction of roads, trench cross Bond and check dam etc. are some of the examples among them





Self employed SHG with preparing different items on use of Bamboos

There are number of SHGs who are strengthening their livelihood by doing vegetable cultivation, goatery, poultry firming, mushroom cultivation etc. 4 SHGs named Mahima Jay Jagannath, Mahima Mangala, Mahima Tarini & Mahima Bajrangbali are comprising of 40 members. All are tribal ladies depend upon forests to maintain their livelihood by selling forest products like Mahua, Bahada, Harida, Anla etc. they are collecting bamboos from VSS forest and preparing the various crafts like Kola, Bojha, tokei, broom with the financial support of Bank Loans of 50,000/-. There was a problem of selling those carfted products in effectual price .Specially they sell it in nearest market, Hata Bazar, Kapilash fair festival etc. But due to the COVID-19 pandemic there was restrictions in opening of these place therefore it would be great riddle to maintain the livelihood. In this situation the PNGO staffs and co-ordinators of OFSDP-II have identified this issue and steped forward in linking with market. With taking this matter SHG member, P-NGO staff, Co-ordinator, Forest Guard cum Member Secretary arranged a meeting with the presidency of RO-cum FMU Chief Kapilash and prepared a plan for marketing the product. A Dealer was identified at Chandi-bazar, Cuttack to whom it was linked to the SHG members to sell their product at Cuttack and fetching good income.



#### Livelihood improvement through vermin compost pits



Nathua Puruna Sahi VSS situated in Sagarposhi GramaPanchayat of Sadar Block in Dhenkanal District under Sadangi FMU.The VSS is consisting of 107 households having heterogeneous community. It is about 12 km distance from National highway & 16km distance from district head office. The keen interest of this community have helped this village got registered as a VSS in the name of Maa Andhari Bauti VSS and also the VSS formed in the year 2019-20 under Sadangi FMU in OFSDP-II project. As per discussion of VSS members about their livelihood status it is found that all the villagers mostly depend upon agriculture for their livelihood. The villagers have got opportunity to start the VSS



under OFSDP –II project in the year 2019-20. All the VSS members keep good relationship with Forest dept FMU staffs & P- NGO representatives. P-NGO team (NYSASDRI) initiated to take a convergence with Gramin Product Marketing (GPM) for improvement of livelihood in the process of Vermi Compost Pit. Now 85 beneficiaries benefited and improve their livelihood through Vermi Compost Pits. Now the VSS members of Maa Andhari Bauti VSS Nathua purunasahi are happy for enhancing their income level and they have thanked to P-NGO team members for developed our income level with the convergence of line dept.

#### CONFLICT RESOLUTION MEETING UNDER FMU-HINDOL

#### Sinkol & Kukupangi

By the intervention, the most important conflict was resolved for the Sinkol & Kukupangi VSS due the forest boundary demarcation. The conflict was basically for forest boundary area which demanded by both villages. The decision could not possible to solve at the individual village level. So the NGO team called a joint meeting of the both villages consisting the villagers and potential leaders. The meeting was attended by the P-NGO staffs and Project Staffs and staffs of Forest Dept where the Villagers discussed the issues and area was demarcated in the presence both VSS and VSS resolution passed to solve the problem.

#### **Baghadharia VSS & Ostapal VSS**

In spite of the regular and frequent interaction with the people in the village Baghadharia VSS the VSS assigned area not finalised due to conflict and mis-understanding with the Otsapala VSS. So the Project team called a joint meeting at Forest Boundary Area, and in front of both Villagers again Survey and Demarcation made. Finally people were satisfied with the GPS area .Now the VSS of BaghadhariaVSS is working very well.

#### **Khanda VSS**

During the period of intervention, by the initiate of the NGO staffs, the conflict of the Khanda VSS was solved as regards to the protect forest area. People were protecting the area more than assigned area which was being protected by them traditionally since 25 years. Since they are protected by them was intervene by the forest dept, people were not interested for the VSS. But after the continuous motivation by the NGO staffs, the problems were mitigated.





#### **Ambithi VSS & Kansara VSS**

The problem of the Ambithi VSS and Kansara VSS was also one of the important issues. Both the VSSs are very near to each others. They had also the problem of the forest area boundary. After a consensus meeting in presence of both village representatives, the assigned area was decided and finalized.



#### Women empowerment through mushroom cultivation at Gulakateni VSS

Galukateni Vana Surakshya Samiti was reconstitueted in the year 2018-19 under OFSDP-II in Kamakhyanagar West FMU. It consists of 336 households with 825 members. Most of them are belongs to Poor Family and depends upon Forest. Consciousness has been created by PNGO team to reduce their dependency upon Forest. In this respect various income generating activities has been taken up for their livelihood enhancement. With the support from OLM & Mission shakti of Kamakhyanagar Block, Mushroom Cultivation was promoted in this village, Bhagyalaxmi SHG, Maa Mangala SHG, Shakti Maa Maheswari SHG, and Baba Khetrapala SHG takes the advantage and prepared Mushroom cultivation. They have been supported Rs 6, 00,000/ - from OLM & Mission Shakti of Kamakhyanagar Block through Covid-19 Assistance.

Bhagyalaxmi SHG, Maa Mangala SHG, Shakti Maa Maheswari SHG, Baba Khetrapala SHG and Shanti SHG of Galukateni VSS use quality spawn in specific method of mushroom bed preparation, grading and packaging of mushroom with harvesting techniques Market linkage by P-NGO Team of Kamakhyanagar west FMU with help of OLM and Mission shakti. Institutional involvement of Krishi Vigyan Kendra Dhenkanal, Horticulture department of Kamakhyanagar, Odisha Livelihood Mission and regular visit by Scientists of KVK Dhenkanal has helped in linking their enterprise with District Mushroom Grower federation.

Now all SHG Members of Galukateni VSS are a successful entrepreneur and became a model village of mushroom production centre of Kamakhyanagar Block. Some SHG Members became a Master Trainer for all line departments and SHG and they are ready to take innovative methods.

Intervention: During the winter and summer season the group was thoroughly trained on Mushroom cultivation starting from cutting, wetting, sterilizing of straw till final bed preparation by OLM/Mission shakti trainer through practical demonstration. The group was also supplied with Mushroom spawn and polythene and field programme and proper follow up for management of beds was conducted.





Output: Total 600 bed per day and average yields of 1.2 kg/ bed in case of paddy straw Mushroom which could fetch them Rs. 160 per bed at the cost of Rs. 60/- which was spent for raising a bed. A net profit of Rs. 96000/- per month and Rs.3200/-per day was quite encouraging to the SHG members. The processes were repeated during the Mushroom season also.25 SHG Members from 4 SHG Groups. The members are getting

@120/- per day in the season and that may vary time to time.

Outcome: The SHG is highly motivated and established regular market linkage with the Mushroom outlets in Kamakhyanagar, Angul and Talcher town. Now they are in the process of supplying 720 kg of Mushroom per Month to the market. SHGs in the nearby area are also impressed with their success.

Impact: The economic return boasted the moral; and self confidence of the rural bodies. They have achieved economic independence

through group action.

Earlier, we couldn't fulfill the needs of the family & children but, when we have started cultivating mushroom & selling it to the market Our incomes Rs 120 per day for each Member of this group working in her mushroom cultivation site told to Miss Purnima Mishra (Development Officer Community Development and Livelihood Support of Kamakhyanagar West FMU) "I don't have any financial problem yet said SHG Members of Galukateni VSS.

#### Women empowerment through vegetable cultivation

Gundichanali Vana Surakshya Samiti was reformed in the year 2018-19 under OFSDP-II in Kamakhyanagar West FMU. It consists of 120 households with 392 members. Most of them are belongs to Poor Family and ST and SC community and depends upon Forest and cultivation. As many as 32 members from 04 self help group (SHG) have scripted a success story by cultivating vegetables at Gundichanali Village under Kanpura Grama Panchayat under Kamakhyanagar West FMU.

These women's now become famous as women's farmers not only in the locality but also in the entire district. Consciousness has been created by PNGO team of Kamakhyanagar West. Various income generating activities has been taken up for their livelihood enhancement, with the support of OLM & MGNREGA of Kamakhyanagar Block. Bank loan and horticulture scheme was promoted in this village. Maa Sarala SHG, Maa Santoshi SHG,Maa Mahalaxmi SHG and Maa Gamharia SHG of this village takes the advantage and prepared at their large patch of land for vegetable cultivation. They have been supported Rs.6,50,000 as labour cost and other invest-



ment from OLM and Mission Shakti of Kamakhyanagar Block through Bank Loan and MGNREGA scheme.

They have started Vegetable Farming in a Large Patch. They grows seasonal, as well as perennial crops like radish, carrot, cauliflower, peas, cowpeas, beans, okra, spinach, coriander, brinjal, tomato, onion, a variety of edible tubers, gourds and greens, FMU chief of Kamakhyanagar west Mr Bibhudananda Mishra visited this farm and all SHG Members said we have now realized that it is our confidence that has taken us far. We put in hard labour as a result of which we are now self employed.

#### **Success story on Ratanpur VSS**

Ratnapur VSS is one of the project VSS under OFSDP-II of Kamakhyanagar west FMU, Dhenkanal Forest Division. In this village people are mostly depends on agriculture for their livelihood. But due to erratic monsoon the crop production of the village are not up to mark. So the youth of the village migrated in neighboring state in search of income. After COVID-19 Pandemic, They came back to their native place and sat idle.

After OFSDP intervention in the village/VSS the 18 no's of young farmers are identified. All of them given rupees 1000/- as COVID-19 assistance from horticulture department through convergence by virtue of which they start their mushroom cultivation individually



with 15 no's of beds, with technical support of AHO Parjang. Further they expanded their bed nos and these people are doing mushroom cultivation till now. Now a days these youth are not going outside of the State for earning.



#### Impact Indicators through the project interventions

- After the training and continuous intervention in the field, the involvement of the people and participation in forest protection has grown up
- The voice of the people and their constructive participation in the meeting is observed at all VSS
- There is sense of competition has grown up at VSS level to put their VSS in better level.
- 4) Women representation was invisible in meeting and other activities, but now women are taking part in the process and trying to put their suggestions in decision making process and leadership.
- 5) By the continuous efforts of the people, the forest is well protected. No such cases of forest theft are ever seen.
- 6) After the successful micro plan training, the working group and people as whole were serious to prepare a micro plan as per their foremost needs.

- Good coordination among the committee members, forest staffs and liaison with other institution increased at VSS level
- 8) Gradually the system of transparency is developing due to the vigilance of the people and committee members.
- After the Community mobilisation and Intervention in VSS level the involvement of people in afforestation in degraded lands and forest protection activities enhanced.
- 10) Many places the VSS made fostland encroached free from influential persons by Activation of VSS EC.
- 11) This project generated employment to in VSS members and Animators and wage reduces migration.
- 12) Communities liasoning has been improved with in different schemes/programmes of different Govt. Departments though convergence



#### Impact on gender mainstreaming

- Both men and women have a sense of unity and transparency in forest protection and conservation.
- 2) During the Epidemic period of COVID-19 many lost their livelihoods as they lost their jobs but due to the implementation of OFSDP-II they had maintained their livelihood by doing project related work in their VSS Forest.
- 3) Similarly many of the Tribal people were uplifted their livelihood by doing forest work.
- 4) By creation of IGA and converging in Mission Shakti & OLM by project attempt many user groups specifically who are maintaining the daily life by doing hand made items like bamboo craft, pottery ,firming etc are able to maintain their livelihood smoothly and happily.
- 5) For gardening cultivation there was a programmed arranged by Kapilash FMU supported by KVK, Dhenkanal at 5 nos. of GP covered by 18 nos. of VSS by distributing COVID-19 package in vegetable seeds & kraits etc.
- 6) For SHGs the project has completed the ranking, grading and scoring of SHGs covering groups were benefited by goatry, poultry farming,, vegetable cultivation, papad business etc through bank linkage and different departments.
- 7) The per capita income of the people has also increased.
- 8) As per capital income, savings have also increased.
- Awareness of forest protection has increased.
- 10) Awareness has been raised about the protection of wildlife animals, birds and plants.
- 11) Young people are being targeted for inclu-

- sion in various government schemes.
- 12) Everyone has been able to control the forest fire despite the reduction in theft in the forest.
- 13) The dependence of people involved in forest products has declined.
- 14) Through "Microplan" the development of the village has seen an improvement in the socio-economic amenities in the village.
- 15) Women have become more self-sufficient and more empowered.
- 16) By doing Honey Bee cultivation, Mashroom cultivation, vegetable cultivation, raise income of WSHG members
- 17) Many of the people benefited in cultivating in their land under the scheme "Moo Upkari Bagicha" by the support of Horticulture department.
- 18) Enthusiasm for the project has been growing in everyone's minds and eternal sustainability has been maintained.
- 19) Apart from this the poorest poor of the Vana Surakshya Samiti are identified at the time of preparation of Micro plan and step towards it by taking strategical initiative plan.



#### **Key learning**

During the field visit, the PNGO team try to collect the feedbacks from the people on the process of discussion. Apart from that the suggestions of the people is also well documented for its implication. During the process of the training, an evaluation format has developed to know the level of people's understanding in the training and how it will be benefitting to the people for the implementation of the activities. As per the interaction with the people on regular basis, it has been realised that VSS are working very well and the team is trying to mitigate the problems as and when reported. Key learning are:

VSSs solve any Conflict situation in a good manner. Keep Records and maintain meeting Resister with proper resolution very well. Committee members take up leadership in any developmental work under VSSs. People are more aware about forest protection, Fire prevention, conservation and implementation of Project. Villagers are involved village perspective plan with preparing micro plan.

PNGO team gained knowledge about save forest conserve forest. Accountability and transparency between forest department and community under the Joint Forest Management Act 2011 and amendment 2015. How to resolve the boundary and inter conflict among village to village etc. Through convergence with concern line department like Mission Shakti and Odisha Livelihood Mission WSHG are taken lot on developmental initiatives. To create Farm Forestry which will be more beneficial for artificial forests to decrease reliance on forest firewood and income to family. Process of conflict resolution between human and wild animal area the area where VSS to learn how to diversify cultivation practices and crop protection through PNGO support.

#### **Major Challenges**

During the project implementation, the PNGO have faced the following challenges like;

- 1) Working in the in assessable with hilly and forest area and movement of elephants in habitant areas.
- 2) Covid pandemic -19 restricted physical meeting training and review of the activities for a certain period.
- 3) During demarcation of forest areas boundary conflict between villages was the key issue to solve by PNGO.
- 4) Political influence during selection of VSS

- assigned forest area, selection of animators,
- 5) At the time of Micro Plan preparation there are number of problems are identifies by Community and expectation also high from the project.
- 6) For IGA it is not to be possible to cover the all beneficiaries under Govt scheme.
- 7) Convergence with other line department is also delayed at departmental level
- Sometimes different opinion arises among coordinator and P-NGO staffs

#### **Future Plan**

- 1) To take the more initiative to prevent soil erosion.
- 2) Increase the amount of initiatives for farm forestry individuals.
- 3) Need for different trade training to increase self employment.
- Develop rain water harvesting structure, solar energy, bio gas,( Renewable Energy) etc
- Encourage the community for rainfed agriculture, organic farming, scientific cultivation and rural craft
